- I, Jack Ewashko, being duly sworn, depose and say:
- 1. I am a Director of Case Management of A.B. Data, Ltd.'s Class Action Administration Company ("A.B. Data"). Under the Scheduling Order entered by the Court on June 25, 2025 ("Scheduling Order"), A.B. Data was authorized to act

as the Settlement Administrator in connection with the settlement of the above-captioned action ("Action"). I am over 21 years old and not a party to the Action. I have personal knowledge of the facts set forth below and, if called as a witness, could and would testify competently thereto.

CONTINUED DISSEMINATION OF NOTICE

- 2. Since the execution of my Initial Mailing Affidavit², A.B. Data has continued to disseminate copies of the Notice of Pendency and Proposed Settlement of Stockholder Class Action, Settlement Hearing, and Right to Appear and Proof of Claim and Release (collectively, "Notice Packet") in response to additional requests from potential members of the Class, brokers, and nominees. Through September 26, 2025, A.B. Data has mailed a total of 28,421 Notice Packets to potential Class Members and nominees.
- 3. In addition, A.B. Data has re-mailed a total of 1,960 Notice Packets to persons whose original mailing was returned by the U.S. Postal Service and for whom updated addresses were provided to A.B. Data by the Postal Service. The U.S. Postal Service has returned a total of 947 Notice Packets as undeliverable for which A.B. Data has not been able to obtain an updated address.

TELEPHONE HELPLINE AND WEBSITE

4. A.B. Data continues to maintain the toll-free telephone helpline, 877-580-7816, with an interactive voice response system ("IVR") and live operators during business hours to accommodate any inquiries from potential members of the Class. Since the administration began on July 16, 2025, A.B. Data has received 116

in-bound calls, which included 84 choosing to speak with A.B. Data's live operators and 32 callers that disconnected after listening to the messages regarding eligibility. A.B. Data has also maintained and monitored the case specific email address, info@DCRBSpacSettlement.com, and will continue to do so for the duration of the administration.

5. A.B. Data also continues to maintain the dedicated website for the Action, www.DCRBSpacSettlement.com, in order to assist potential members of the Class. On August 29, 2025, A.B. Data posted to the website copies of Plaintiff's Opening Brief in Support of Motion to Approve the Proposed Settlement, Certify the Class, and for an Award of Attorneys' Fees and Expenses and Incentive Award and the Revised [Proposed] Order and Final Judgment (along with the redlined version of the Judgment). A.B. Data will continue maintaining and, as appropriate, updating the website and toll-free telephone helpline until the conclusion of the administration.

OBJECTIONS

6. The Notice and Settlement website also inform Class Members that they may object to the Settlement, the proposed Plan of Allocation, and/or the requested Fee Application. The objection must be in writing and filed with the Register in Chancery, with copies of said objection served upon counsel, no later than September 19, 2025. Through September 26, 2025, A.B. Data has been informed of one objection from Dr. Alfred Miller.
